3. **Please note that Miss California USA no longer has any preliminary directors at the local level. So the new titleholders will be allowed to go to any California State Pageant, International System, United States, Collegiate or USA.**
4. **Entry Fee: \$375. entry fee includes the DVD & Photos for Teens, Miss and Mrs. \$350.00 IF PAID BY 5/21/18.**
5. **\$95.00 entry fee for the 6 to 13 year olds. All checks payable to Debra Dodge or Extras. Contact us to pay with debit or credit card.**
6. Please organize your sponsors ASAP in order to get their information and business cards in the pageant program.
7. All fees are due no later than May 21, 2018 and are not refundable. Any fees received after this date will NOT guarantee photo and sponsor information in pageant program.

5. RULES, RELEASE AND AGREEMENT

12. CHECKLIST – KEEP!!!! KEEP!!!

Below is a list of items you MUST have on the day of the pageant(s). Use this list as a guide and checklist as you prepare for the pageant(s). It is always a good idea to use it again as a checklist the night before and/or the morning of the pageant(s). Before you leave your house double check that you have EVERYTHING that you will need for the day. If you have any questions, please feel free to call any member of the Pageant Staff.

1. Interview Outfit Teen, Miss & Mrs.– Will be worn for your daytime interview.
2. Stage Introductions: You will wear your Interview Outfit that was worn in your Judges Interview. for on stage introduction for Teen, Miss and Mrs.
3. A cute dress for the Princesses and Jr. Miss. For evening on Stage introduction, Crowning, etc.
4. Teen is now changed to a 2 piece sportswear outfit. We are requiring any color spandex shorts with any color sports bra type top, with tennis shoes.
5. Miss: Two piece Swimsuit (NO THONGS). Shoe: Taupe Shoe or Taupe Sandal.
6. **Mrs. Contestants will be 2 piece sportswear similar to Mrs. California International Pageant and white tennis shoes. Longer spandex shorts, sports bra or sports top and tennis shoes.**
7. A cover-up (something warm & comfy).
8. Rehearsal Clothing (comfortable).
9. Evening Gown - must be floor length.
10. Shoes for each outfit
11. Limited space for Rolling Racks and extension cords.
12. Hair and Make-up equipment (hot rollers, curling irons, hair spray, hairpins, brushes, hairspray, extension cords, etc.) Power strip for curling irons, etc.
13. Pageant Hair and Makeup Crew will be available at the pageant at an additional cost. No other outside hair or makeup people will be allowed.
14. ALL personal hygiene products.
15. Snacks/Lunch/Water - you will not be allowed to leave, so it is a good idea to bring your own snacks. If you have any special dietary needs, be sure to bring whatever you may need. **Pending the amount of contestants and the time you will be required to appear on 7/14/18, lunch and water for the contestants and staff may be provided.**
16. Mirrors - you have some mirrors at the center. You may bring a small mirror, DO NOT rely on using someone else's mirror. BE CONSIDERATE OF YOUR FELLOW CONTESTANTS.

17. All of your belongings in one (1) rolling suitcase or bag and one garment bag. There will not be enough room in the dressing room for each delegate to have several bags or suitcases lying around.

18. **EVERYONE is responsible for cleaning up the dressing room.** Please bring along a small plastic trash bag and keep it near you for your own personal trash, Q-tips, make up sponges, kleenex, water bottles, etc. and dispose of that in the large trash receptacle on your way out. The Staff is there to HELP YOU, NOT clean up after you. Once you are in your Evening Gown, please pack up all of your things. When the pageant is over we all need to clear out of the facility quickly so please work toward that by packing as you go along in the evening. If you win you are not going to want to have to pack up after photos as there is a party waiting for you.
